
# **GUIDED HIKE** & LUNCH


#### TRIAL SKILLS REFRESHER SERIES\*

Against All Tides: The Untold Story of USS Kitty Hawk Race Riots (A Defense Attorney's Perspective)





SPEAKER: Marv Truhe is a farm kid from South Dakota. He received a mechanical engineering degree, with honors, from the South Dakota School of Mines and Technology, which later awarded him an honorary doctorate. He is a graduate of Northwestern University Law School where he was a member of the Law Review. He then served as a US Navy JAG officer and military judge during the Vietnam War.

Marv's book, *Against All Tides, The Untold Story of the USS Kitty Hawk Race Riot*, exposes the racial injustices perpetrated against 25 Black sailors who were charged with rioting aboard the *Kitty Hawk* in 1972 while it was conducting bombing runs into North Vietnam. His first-person account chronicles the incident and his defense of several of those sailors at their courts-martial trials. His book website, marvtruhe.com, contains additional photographs and details.

Following his military service, he led the trial division of the South Dakota Attorney General's Office. He next practiced law in Rapid City, South Dakota, specializing in insurance defense, construction litigation, and corporate, mining, and environmental law. Following his retirement, he and his wife moved to Colorado where their son Eric's family lives. Eric and his wife Leigh (Trueblood) are 2001 graduates of DU Law School.

# Lessons from Darrow: Ethics and Advocacy in the Courtroom\*



SPEAKER: Sandy Brook is a former Chief Judge of the Indiana Court of Appeals. Sanford M. "Sandy" Brook served sixteen years on the bench in Indiana. Twelve of these years were spent on the trial bench in South Bend, Indiana, where he also served three years as Chief

Judge. As a trial judge Sandy presided over 190 jury and 350 bench trials, and he authored over 275 appellate opinions while on the Indiana Court of Appeals. While a judge, he promoted alternative dispute resolution in the Indiana court system by serving as a judicial mediator and conducting numerous settlement conferences at both the trial and appellate levels.

Since 1987, Sandy has taught extensively in the areas of Evidence and Trial Advocacy. He has been an Adjunct Professor at both the Notre Dame Law School and the Indiana University Law School in Bloomington, and has taught Evidence in the Indiana Bar Review Course. Brook has also taught advocacy internationally in Canada, England, Scotland, Northern Ireland, Thailand and China with the National Institute for Trial Advocacy (NITA), and was an Adjunct Faculty member at Nottingham Law School in England.

Sandy has had a lifelong interest in acting and the theater. Referring to acting as a "secret passion," he has studied Courtroom Theater in an unusual way — as a trial lawyer, trial judge, and trial advocacy instructor. His real-life experience with the art of storytelling and persuasion, coupled with this commitment to the critical importance of an independent judiciary, makes his presentation of Clarence Darrow a natural fit. Sandy has performed "Darrow" for audiences in Indiana, Illinois, Colorado, and Florida. The play brings to life the emotion, oratory skill, and courtroom drama of an extraordinary man, Clarence Darrow, who exposed inequality and injustice by taking on society's most controversial causes.

Sandy creatively uses portions of the play as a backdrop for a memorable and instructional CLE. His passion and commitment to the critical importance of an independent judiciary as well as his strong belief that our profession has a continuing obligation to assist those most in need are exemplified in his performance of "Darrow."







PANELIST: Franklin D. Patterson, Esq. is the founding partner of Patterson Ripplinger, P.C. He is acknowledged by peers as a leading personal injury and bad faith defense lawyer in Colorado. Frank handles substantial exposure liability and injury cases such as his defense of the parents of

one of the Columbine shooters. He is consulted by major insurers for coverage opinions and advice, and is regularly retained as an expert witness on insurance industry standards.

The list of appellate decisions on his cases cover all of the key insurance and litigation issues over the past 30 years. The Court of Appeals, Supreme Court and 10th Circuit Court of Appeals have chosen many of his cases for public oral arguments in high schools and law schools. Frank was the youngest member ever selected to the American Board of Trial Advocates. He is a past president of the CDLA and has volunteered countless hours of his time to the Colorado legal community through numerous speeches, seminars, articles, and serving on committee, and associations throughout his forty-year career.

Born in Indiana, Frank received his BA from Earlham College. He came to Colorado in 1978 with his wife Robin to attend law school. They immediately fell in love with the State and it has been home ever since. While at the University of Denver he earned his J.D. in 1981, and a Master in Judicial Administration in 1982.

Karen is also active in estate and business planning.

Karen is and active leader in state and national bar associations, and a philanthropic contributor to the community. She is a member of the American Board of Trial Advocates, among numerous other honors. She served on the Board of Directors of the CDLA for over a decade. She is a past president of the CDLA and a former Colorado State representative for the National Defense Research Institute. She has held many other respected positions in various legal, educational, and community associations.

the legal field, Ryann focused their law practice on civil litigation with an emphasis on LGBTQ+ families and civil rights.

Ryann has been routinely recognized for their legal practice, most recently earning the American Bar Association Rosner & Rosner Young Lawyer Professionalism award and the IDEA Leader in the Community award from The Center on Colfax. Ryann sits on the boards of several Colorado non-profit legal organizations and serves as the 2022 President of the Colorado Bar Association. # The New Age of Remote Proceedings – Pitfalls, Pros, and Cons\*





SPEAKER: Honorable Susan Blanco is the Chief Judge of the 8th Judicial District of Colorado and is the first female chief judge for the district. She has presided over criminal, civil, probate, domestic relations, and specialty courts. Prior to the bench, she served as Deputy District Attorney

followed by over a decade in private practice

focusing on criminal defense, juvenile delinquency, dependency and neglect, and municipal prosecution. She developed the first Competency Court in Colorado and the award winning Latinx task force focused on improving access to justice. She helped develop and launch the DEI initiative "Lawyer's Teaching for Change" which allows attorneys to teach about the law in grade school classrooms. Currently she serves on the Chief Judge's Council, is a commissioner on the Colorado Access to Justice Commission, the CBA Criminal Law Executive Council, the CWBA Board of Directors, chairs the Colorado Judicial Branch's Pathways to Access Standing Committee working on virtual proceedings, language access, and plain language forms, and cochairs the Colorado Judicial Branch's IT Standing Committee.

The use of technology and remote proceedings accelerated rapidly in the wake of the global pandemic. As remote proceedings are becoming widely used in many jurisdictions, attorneys must learn/adjust their trial practice skills to embrace the technology. Chief Judge Blanco will share her knowledge gained from presiding over trials, as well as her involvement with the Judicial Branch IT Standing Committee related to remote trial proceedings, impacts on the judiciary, and related developments.


